DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#28 is a 1-1/2 story frame house, detached on the left (E), four bays wide, and two bays in depth with a one story, frame "L" shaped wing, two bays wide and four bays in depth with a small side extension. The general size and shape of this building indicates this to have possibly been built as a log house. It is now covered by composition shingles. A simple front entrance occupies the second bay from the right (W) with a Colonial type, six panes over panels, and a high covered porch extends across the front. All house windows are of 6/6 sash and have louvered shutters. The attic is well lighted by two peaked dormer windows also with 6/6 sash on the front and by two small 6/6 sash windows in the left gable. The front section has a steep "A" frame roof and the wing has a shed roof, both of metal. A small enclosed chimney rises from each gable. This house rests on a high fieldstone foundation. It is fronted by a herringbone patterned pavement.
