DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of brick two story houses detached on the right (W) and is four bays square with a two story brick "T" shaped wing, three bays wide and two bays deep with rear balconies. All brickwork is of unpainted common bond. Simple entrances occupy the inner bays with paneled doors, white marble steps, large rectangular transoms and are headed by segmental arches of three row headers with infills decorated by roundels, as are all front windows. The windows are all of 1/1 sash and rear windows are of 6/6 sash with segmental arches of two row headers, and there are glass/panel doors with four pane overlights. The front section roof slopes to the rear with the wing having a low "A" frame roof, and both are of metal. The front cornice is "V" shaped with bands of moulding, dentils, and pointed scallops. Scrolled, fluted brackets accent the bays with end brackets decorated by crockets bearing carved roundels topped by acroteria. The front cellar entrances are paired with windows headed by wide, brick, segmental arches and infills decorated by roundels. This building rests on a high fieldstone foundation. It is fronted by a herringbone patterned brick pavement.
