**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a pair of two story, approximately four bay square, brick houses, detached on the right (E) side. They share a two story brick "T" shaped wing, three bays wide and two bays deep with side balconies. All brickwork is in common bond. Round arched entranceways occupy the outer bays with newer doors and transoms. The inner bays contain round arched, double windows with moulded mullions decorated by roundels. All front windows are of 1/1 sash and those on the second story are segmentally arched with incised infills. The sides and rear of the front section have 2/2 sash windows. Those on the wing of #31 are of 1/1 sash and #33 has 6/6 sash windows, both with wood lintels and sills. The front section roof slopes to the rear and the wing has a low slope "A" frame, both of metal. The front roofline has a Victorian cornice with bands of incised designs, including crosses, and moulded brackets accent the center and ends which are topped with acroteria. This building rests on a rather high fieldstone foundation and is fronted by a herringbone patterned brick pavement.
