DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#32 is a 2-1/2 story brick house detached on the left (E) side and is three bays wide and two bays in depth with a two story, "L" shaped wing, two bays wide and five bays long with a side balcony. The front entrance occupies the right bay with a four paneled door with top panels rounded and is reached by a high wooden porch. Beneath this porch is a board and batten cellar door and board and batten shuttered window. All house windows are now of 1/1 sash with wood lintels and sills. The front section has a moderate slope "A" frame roof resting on a three string brick cornice on the front and a two string on the rear. A small chimney rises from each gable. The wing has a shed roof. This building sets on a high fieldstone foundation. Brickwork is of common bond.
