DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#34 is a tall, 2-1/2 story brick house detached on the right (W). It is three bays wide and two bays deep with a two story brick "L" shaped wing, two bays wide and four bays long with the remains of a side balcony, a one bay square brick extension and newer additions. The front entrance occupies the central bay with a newer door reached by a high wooden porch. All front windows are now of 1/1 sash with 6/6 and 1/1 sash in the rear areas, all with wood lintels and sills. The attic is lighted by a small, four pane window in the right gable. The front section has a steep slope, metal roof resting on a three string brick cornice on the front and a two string on the rear. An enclosed double flue chimney rises on the left side. This house sets on a very high fieldstone foundation. Brickwork is in common bond.
