DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#36 is a 2-1/2 story brick house detached on the left (E) side, approximately three bays square with a two story, brick "L" shaped wing, three bays in depth and two bays wide with a side balcony and a one story, one bay square extension. All brickwork is in common bond. There is a paneled door in the right bay with a one pane overlight, and it is reached by a high wooden porch. There are now 1/1 sash windows on the front first floor and 6/6 sash windows on the second story, all with top moulded lintels. On the rear area are 6/6 sash windows with regular wood lintels and sills and louvered shutters. There is a rear, four panel door with an old, four pane overlight. The attic is lighted by two, six pane sash in the left gable. The front section has a steep slope "A" frame roof of asphalt shingles resting on a three string brick cornice on the front and a two string on the rear. A small enclosed chimney rises from the left gable. The wing has a metal shed roof. This house rests on a low fieldstone foundation. It is fronted by a herringbone patterned brick pavement.
