DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#37 is a detached, 2-1/2 story, frame house, possibly of log construction according to a neighbor. It is five narrow bays wide and two bays in depth with a two story, frame "L" shaped wing, three bays wide and one in depth with a one story side extension and a rear balcony. This house is now covered by composition siding. The simple front entrance occupies the third bay from the left (W) with a four panel door, top panels rounded, and a boarded-in overhead. All front windows are of 6/2 sash with projecting moulded cornices with dentil trim. Rear windows are of 6/6 sash. There is a side, four panel door and rear window in the left gable and a pair of four paned windows on the right. The front section has a moderate slope "A" frame roof (metal) with a small enclosed chimney rising from the left gable. This is fronted by a boxed cornice with dentil trim. The house rests on a rather low fieldstone foundation. It is fronted by a herringbone patterned brick pavement.
