DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#39 is a 2-1/2 story detached frame house, three bays wide and two bays in depth with a two story, frame "L" shaped wing, one bay wide and two bays in depth with a side balcony. The house is covered by clapboarding except for newer siding on the left side. This may have been constructed as a log house. A simple entrance occupies the center bay with a four panel door with top panels rounded and a narrow overlight. This is reached by a wooden stoop. Front and rear windows are of 2/2 sash and the attic is lighted by a small, four pane window in the right (E) gable and the front facade is topped by a central, large, peaked dormer with a peaked 2/2 sash window. Other front windows are headed by a shallow cornice centered with a half-round, wooden "keystone," enclosing a roundel. The front section and the dormer window have steep sloped "A" frame roofs of asphalt shingles and the wing has a shed roof. A small enclosed chimney rises from the right gable. The front roof-line has a boxed cornice and the peaked dormer is decorated by a decorative pendant. This house rests on a rather low fieldstone foundation. The front pavement is laid in a herringbone pattern of brick.
