DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of 2-1/2 story frame houses, detached from others, four bays wide and two in depth with a two bay square, 1-1/2 story frame "T" shaped wing. The old siding has been covered with asphalt shingles. Very simple front doorways occupy the inner bays with newer doors. All front windows are of 6/6 sash with either 6/6 or 1/1 sash in the wing or rear area. The front section has a moderate slope "A" frame roof with small enclosed chimneys on each end and enclosed by boxed cornices with an extending ornamental Victorian, barge board design. The attics are lighted by two small, four pane windows in each gable. The wing has a steep slope "A" frame roof and both are of metal. This building rests on a high fieldstone foundation.
