DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story brick pair of houses, four bays wide and three byas in depth with a two story, brick "T" shaped wing three bays wide and two bays in depth with side balconies. All brickwork is of common bond. The front entrances occupy the inner bays with newer doors and segmental arched transoms. They are approached by attractive Victorian-style, four step, wooden porches with turned banisters and newels. On either side on the first and second stories are very wide windows with those of regular size above the doors. All are of 1/1 sash, have dentiled transom bars and flat topped segmental brick arches. Rear and side windows are of 2/2 sash with louvered shutters and two row brick segmental arches, some with infills decorated with roundels and incised circles. The front section has a broad, moderate-sloped, slate "A" frame roof resting on three string brick cornices with the middle row on the front in a dentil design. Enclosed double flue chimneys decorated with wide bands of corbelling rise on either side on the front slope of the roof. The wing has a low "A" frame roof of metal. The building sets on a rather high fieldstone foundation. There are flower gardens to the rear.
