DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of brick houses detached on the left (S) side, four bays wide and approximately three bays in depth with a 2-1/2 story brick "T" shaped wing four bays in depth and three bays wide with side balconies. All brickwork is in common bond. Simple front entrances occupy outer bays with an original four panel door on #433 and tall three pane overlights and wood lintels and sills. Front windows of #433 are now of 1/1 sash below and 6/6 sash above, all with louvered shutters. #435 now has a wider 1/1 sash window on the first floor and 6/1 sash above, all with wood lintels and sills. Rear windows retain their 6/6 sash with wood lintels and sills. The front attic is lighted by two four pane windows in the left gable and the wing attic has a similar window in the end. Front and wing sections both have moderate slope "A" frame metal roofs with the front section resting on three string brick cornices. Double flue enclosed chimneys rise from each end. The houses rest on a low fieldstone foundation.
