**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached, two story pair of brick houses, four bays wide and four smaller bays in depth with a two story brick "T" shaped wing, three bays wide and two bays deep with rear balconies. All brickwork is in common bond. Front entrances occupy the inner bays with newer doors and segmental arched transoms. On either side are sets of double, segmental arched windows with ornate infills composed of roundels and incised scrollwork. #104A retains an ornate moulded mullion. The upper story has single, segmental arched windows and all front fenestrations are headed by three row header brick arches. There are 6/6 sash windows in the rear area, all with two row header, segmental brick arches. The front section roof slopes to the rear and the wing has a low slope "A" frame. This building sets on a rather high fieldstone foundation.
