**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#105 is a 2-1/2 story brick house detached on the left (W) side, three bays wide and two bays in depth with a two story, brick "L" shaped wing, two bays wide and five in depth and a side balcony. All brickwork is in common bond. A wide entranceway occupies the right bay with a rectangular transom, a vestibule, and a pair of Victorian moulded glass paned doors. First floor front windows are tall and narrow and of 1/1 sash. Those above are shorter and of 2/1 sash, all with brick segmental arches with infills decorated by pairs of roundels and incised decor. Rear area windows are of 2/2 sash with two row segmental brick arches except for newer, wide sections of small paned sash on the first floor. The attic is lighted by two, four pane windows in the left gable. The front section has a steep slope "A" frame roof resting on three string brick cornices with a brick frieze on the front in the design of alternately recessed bricks forming dentils. Enclosed double flue chimneys rise on either side. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
