DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#107 is a tall, 2-1/2 story brick house detached on the right (E) side, approximately three bays square with a two story brick "L" shaped wing, two bays wide and three in depth and a side balcony with Victorian-cut banisters and a one story, frame extension. All brickwork is of common bond. The front entrance occupies the left bay with a newer door and a segmental arched transom. There are tall, narrow windows to the right with 2/1 sash, the top sections being 1/3 of the total height. Above these are regular, 2/2 sash windows with segmental shaped louvered shutters, and all have segmental brick arches, as above the door. Rear windows are also of 2/2 sash but have wood lintels and sills. The attic is lighted by a small, four pane window in each gable. The front section has a steep "A" frame roof resting on two string brick cornices. The wing has a shed roof and both are of metal. This house rests on a rather high fieldstone foundation and is fronted by a herringbone brick pavement.
