DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#109 is a 2-1/2 story detached frame house, three bays wide and two in depth with a 2-1/2 story, frame "L" shaped wing, 2-1/2 bays wide and two bays in depth with a side balcony and newer, one story block extension. The front and sides are now sheathed with aluminum siding and the rear area with weatherboarding and asphalt shingles. A newer door with a narrow overlight occupies the center bay, and all front windows are of 2/1 sash with the few rear windows being of 6/6 sash. The attic is lighted by a four pane window in each gable and in the rear. Both roof sections have steep, metal-covered "A" frames. Small enclosed chimneys rise on each end. The house sets on a high fieldstone foundation and is fronted by a herringbone patterned brick pavement.
