DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#111 is a tall, 2-1/2 story brick detached house approximately three bays square with a two story brick "L" shaped wing, two bays wide and six narrow bays in depth with a side balcony. All brickwork is in common bond. The front entrance occupies the left (W) bay with a newer door and a segmental arched transom. Front windows are now of 1/1 sash with the first floor windows taller than those above and all have segmental brick arches, as above the door. Rear windows are of 2/2 sash with wood lintels and sills, and there are four panel doors with two pane over-lights. The attic is lighted by a four pane window in each gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with the middle row of the front being laid on the diagonal. Small enclosed chimneys rise at each end. The wing has a shed roof and both are of metal. The house sets on a high fieldstone foundation, and the front cellar windows have cast iron grills with decorative male cherubs protruding from the centers.
