DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#113 is a 2-1/2 story detached brick house three bays wide and two bays in depth with a two story brick "L" shaped wing, two bays wide and five narrow bays in depth with a side balcony and a newer, one story brick extension. All brickwork is in common bond and has recently been restored. The front entrance occupies the left (W) bay with a newer door and a covered, segmental arched transom. To the right are two tall and narrow 1/1 sash windows and those above are regular-sized, 2/2 sash windows. All have brick segmental arches as above the door. Rear windows are of 6/6 sash with wood lintels and sills, and there is a four panel door. The attic is lighted by a four pane window in the right gable. The front section has a steep slope "A" frame roof resting on three string cornices and small enclosed chimneys rise at each end. The wing has a shed roof and both are of metal. The house sets on a rather high fieldstone foundation.
