DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of brick houses detached on the right (N) alley side, four bays wide and approximately three bays in depth with 1-1/2 story brick "U" shaped wings three bays in depth and 1-1/2 bays wide with #501 extended by a block store addition and a full second story. This apparently is one building with a visible seam on the front facade only, and all is in common bond. The newer shop area has a central entrance with large pane windows and #503 has a newer door in the right bay with an old paneled enframingent, four pane overlight, dentiled transom bar, and topped by a wood lintel with the top moulded and trimmed with dentils as are all front windows, as is its neighbor at #505. There is an old 6/6 JIB-window-door on the rear of #503 and the first floor of this wing has 6/6 sash with three low 4+4 sliding casement "lie on your stomach" windows on the top floor. The attic is lighted by a 6/6 peaked dormer window in the center of the rear roof of both houses and by two large windows on the right side (501). The front section has a moderate slope "A" frame roof resting on three string brick cornices with the bottom row in front in a dentil pattern (as on 505 & 507). A double flue enclosed chimney rises from the right gable. The wing has a shed roof resting on a two string brick cornice and both are of metal. This building rests on a low fieldstone foundation.
