**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#115 is a 2-1/2 story detached brick house, three bays wide and two bays in depth with a two story, brick "L" shaped wing, two bays wide and four bays in depth, a side balcony and a newer, one story frame extension. All brickwork is in common bond and has been restored. A simple front entrance occupies the left (W) bay with a newer door and segmental arched transom. All front windows are now of 1/1 sash with those on the first floor being taller than those above and all have segmental brick arches as above the door. Rear windows are also of 1/1 sash but with wood lintels and sills, and the attic is lighted by a small, four pane window in each gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with that on the front having the middle row laid in the diagonal. Double flue enclosed chimneys rise on each end. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
