DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses detached on the left side, five bays wide and with #119 being three bays and approximately three bays in depth. It has a two story, brick "T" shaped wing, four small bays in depth and four wide with side and rear balconies. All brickwork is in common bond. Newer doors with segmental arched transoms occupy the left bay of each house, and there is an enclosed passage to the rear yard in the right bay of #119. Front windows are now of 1/1 sash with segmental brick arches, but the center window of the second story of #119 is now bricked in. Rear windows are a combination of 6/6 and 2/2 sash. The attic of #117 is lighted by two, four pane windows in the left (W) gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with a small enclosed chimney rising to the right of each house. The wing and one story, newer extensions have rather flat roofs and all are of metal.
