DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#118 is a detached, two story brick house, three bays wide and two bays in depth with a two story, frame "L" shaped wing, 1-1/2 bays wide and three bays in depth, a side balcony, and a one story, frame extension. The front section is laid in common bond and the wing areas are clapboarded. The simple front entrance occupies the right (W) bay with a newer door and a narrow, segmental arched overlight. All front windows are now of 1/1 sash with two row header brick segmental arches, as above the door. The rear of the front section has 1/1 and 6/6 sash windows while those on the wing are of 2/2 sash. The front section roof slopes to the rear with a small enclosed chimney on the left, and the wing has a shed roof, both of metal. The front roofline has a Victorian, "V" shaped cornice decorated by bands of dentils, incised diagonals and mouldings with a band of patera (flat discs) at the base of the frieze. The house rests on a low fieldstone foundation.
