DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses, six bays wide and three bays in depth with a two story, brick "L" shaped wing extending from the left bay of each house. These are two bays wide and three bays in depth with side balconies (removed from #121). All brickwork is in common bond. Newer doors occupy the left bay of each house with high enclosed passageways to the rear yards in the right bays. Front windows are of 1/1 sash on the first floor and 2/1 sash on the second story, all with segmental brick arches. Rear windows are of 6/6 sash. The front section has a moderate slope "A" frame roof resting on three string brick cornices with small enclosed chimneys rising at each end. The roof of #121 is covered by asphalt shingles, and #123 by metal. The wings have shed roofs and are of metal. The building rests on a low fieldstone foundation.
