DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick pair of houses approximately four bays square with a two story, brick "T" shaped wing, three bays wide and two bays in depth and rear balconies, enclosed on #122. All brickwork is of common bond. Front entrances occupy the inner bays with glass over panel doors. On either side are double sets of windows. All front windows are of 1/1 sash with two row header brick, segmental arches having infills adorned with roundels. Rear and side windows are a mixture of 1/1, 6/6, and narrow 2/2 and 4/4 sash, all with arches similar to the front. The front section roof slopes to the rear and is decorated at the roofline by a moulded cornice and frieze with bands of dentils and small patera (flat discs). The bays are divided and ended by ornate Victorian-cut brackets. The wing has a low "A" frame roof and both are of metal. The building rests on a low fieldstone foundation and #124 is fronted by a herringbone brick patterned pavement.
