DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#129 is a 2-1/2 story brick house detached on the right side except for a one story, "fill-in" frame building. It is three bays wide and two bays in depth with a two story brick "L" shaped wing, two bays wide and four in depth with a long side balcony and a two bay frame extension. All brickwork is in common bond. The front entrance occupies the left (W) bay with a newer glass over panels door, a segmental arched transom, and a scalloped transom bar. Front windows are of 2/2 sash with segmental brick arches as above the door. A cellar window grate is adorned with a three dimensional "male cherub" made at a local foundry. Most rear windows remain 6/6 sash except for newer sets of 4/4 double windows, and all have wood lintels and sills. The attic is lighted by a small, four pane window in the exposed gable. The front section has a steep slope "A" frame roof resting on three string brick cornices with the middle row on the front being laid on the diagonal. Small enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house rests on a low brick-faced fieldstone foundation.
