DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#130 is a small, 2-1/2 story frame house attached on the left (E) side and is three narrow bays wide and one bay in depth with a two story, frame "L" shaped wing, two bays wide and three bays in depth with a side balcony and a one story extension. The building is now covered by brick patterned asphalt shingles. A low pavement level doorway occupies the right bay with a newer door. All house windows are of small 6/6 sash and the attic is lighted by a small, four pane window in the right gable. The front section has a steep slope, metal "A" frame roof with an enclosed double flue chimney rising at the left side and the wing has a shed roof. The house rests on a low fieldstone foundation.
