DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#131 is a detached, 2-1/2 story brick house with a small "fill in" frame building to one side. It is approximately three bays square with a two story brick "L" shaped wing, two bays wide and approximately four in depth and a side gallery. All brickwork is in common bond with the front facade ornamented by pressed brick. The front entrance occupies the left bay with a six panel door as on the rear and the transom is now covered. Front windows are now of 1/1 sash with brick segmental arches, as above the door. Rear windows are of 6/6 sash with wood lintels and sills. The attic is lighted by a small, four pane window in each gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices with the center row on the front laid on the diagonal. Small enclosed chimneys rise on each end. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
