DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#132 is a small, 2-1/2 story frame house attached on the right (W) side, two bays wide and one bay in depth with a two story frame, full-width wing, one bay deep, a two story, one bay square extension and a shed-roofed, one story frame extension. The front facade is now sheathed with asbestos shingles, the exposed left side with embossed metal shingles of an unusual design, and the wing has either clapboards or plain wood siding. A newer door occupies the left bay with a newer, large window to the right. The second story and rear areas have small 6/6 sash. The attic is lighted by a small, four pane window in the left gable. The front section has a steep slope, "A" frame roof with the wing and extensions having shed roofs, and all are of metal. The house rests on a low fieldstone foundation.
