DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#200 is a small, 2-1/2 story frame house detached on the alley side. It is two bays wide and approximately three bays in depth with a full-width, two story frame wing, two bays in depth. The house is now sheathed with asphalt shingles. A simple glass over panels door with a rectangular transom occupies the right (W) bay. All house windows are of 2/2 sash with some having louvered shutters. The front section has a low slope "A" frame roof with a small enclosed chimney rising at the right gable. The wing has a shed roof and both are of metal. The front cornice is boxed with a band of dentils crossing beneath it. The house rests on a low fieldstone foundation.
