DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#202 is a small, 2-1/2 story frame house detached on the left (E) side. It is two bays wide and approximately three in depth. It is sheathed with clapboarding. A simple, glass over panels door decorated by a low dentiled pediment, occupies the right bay. All house windows are of 2/2 sash with the attic being lighted by a small, four pane window in the left gable. The house is covered by a moderate slope metal "A" frame roof and a small enclosed chimney rises at the right side. It rests on a low foundation of mixed stone.
