DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a row of four, two story brick houses attached on the right (E) side, eight bays wide and approximately four in depth. Each pair of houses shares a two story, brick "T" shaped wing, four narrow bays wide and two bays in depth with end galleries. All brickwork is in common bond. Simple front entrances occupy the inner bays of each pair of houses with period or newer doors and narrow overlights. All house windows are of 1/1 sash with wood lintels and sills. The front section roof slopes to the rear and the wing roofs are rather flat, all being of metal. The front roofline has a boxed cornice and is decorated by a band of dentils. Moulded and cut brackets divided and end the houselines. The building rests on a low field-stone foundation.
