DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, brick pair of two story houses, four bays wide and approximately five in depth with rear balconies. All brickwork is in common bond. Simple front entrances with glass over panel doors occupy the end bays. All house windows are of 1/1 sash with two row segmental brick arches as above the doors. The metal roof slopes to the rear fronted by a boxed cornice adorned by a band of dentils. The building rests on a low fieldstone foundation.
