DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#509 is a tall, 2-1/2 story brick house detached on the left (S) side and is three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays in depth with a side balcony. All brickwork is in common bond. The front entrance occupies the right bay with a four panel door and segmental arched transom. The whole is enclosed by a wide moulded architrave. Front windows are new of 1/1 sash on the first floor and 2/2 sash on the second story, all with louvered shutters and segmental brick arches. Rear windows are all of 6/6 sash with wood lintels and sills. The attic is lighted by two 6/6 sash windows on the left side. The front section has a rather steep "A" frame roof resting on three string brick cornices. A double flue enclosed chimney rises from the left gable. The wing has a shed roof and all is of metal. The house rests on a low fieldstone foundation but has rather high brick cellar walls. This house is fronted by a herringbone brick patterned pavement.
