DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#235 is a small, detached, 2-1/2 story frame house, two bays square with a two story "L" shaped frame wing, one bay wide and three bays in depth with a one story frame extension. All sheathing is of clapboarding. The former front doorway has been converted to a window with the house now being entered by several side entrances. All windows are of 2/2 sash and the attic is lighted by a small, four pane window in each gable. The front section has a moderate slope "A" frame roof and the wing has a shed roof--both of metal. This house rests on a low field-stone foundation and is fronted by a herringbone patterned brick pavement.
