DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story brick houses, six narrow bays wide and two bays in depth with a two story, brick "T" shaped wing, four bays wide and three bays deep with side balconies (#6 now enclosed). All brickwork is in common bond. Front entrances occupy the center bays with newer doors, granite sills, and segmental arched overlights. These are approached by old cast iron ornamental porches. All front windows are now of 1/1 sash, have louvered shutters and are headed by segmental brick arches of two row headers and infills are decorated by raised panels and roundels, as above the doorways. Rear area windows are of 2/2 sash with segmental brick arches as on the front. The attics are lighted by small four pane windows in each gable. The front section has a steep slope "A" frame slate roof resting on three string brick cornices with small enclosed chimneys at each end. The wing has a low "A" frame roof. This building sets on a low fieldstone foundation.
