**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#7 is a 2-1/2 story detached frame house, four bays wide and two bays in depth with a 2-1/2 story frame "L" shaped wing, six short bays long and two bays wide with a side balcony and small, one story extension. The whole is now covered by new clapboarding. A simple front entrance occupies the second bay from the left (W) side with a newer door. All house windows are of 2/2 sash. The front section and wing have steep slope "A" frame roofs with the front being of metal with small enclosed chimneys rising from each side and the wing is covered by asphalt shingles. The front attic is lighted by a small, four pane window in each gable and boxed cornices frame the roofline. This house has a low foundation.
