DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#8 is a two story brick detached house, three bays wide and two bays in depth with a lower, two story brick, off-centered, "T" shaped wing, two bays square and a rear extension. All brickwork is in common bond. The simple front entrance occupies the left bay with a newer door, narrow overlight which is segmentally arched, and a granite slab porch. All front windows are of 1/1 sash with segmental brick arches of two row headers with infills decorated by incised scrolls centered by roundels, as over the doorway. Rear area windows are of 2/2 sash with wood lintels and sills. The front roof section slopes to the rear and the wing has a rather flat roof. The front roofline has a Victorian, "V" shaped cornice decorated by mouldings and bands of incised designs with three large, moulded brackets. The house rests on a low fieldstone foundation.
