

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This small brick structure was initially built as an office for Hammacker Brothers Memorials and is positioned back from the street.

It is 1-1/2 stories in height with the gable facade facing the street. There is a centrally positioned entrance door flanked by two proportionately large 6/6 sash windows; the door, initially narrower, appears to have been enlarged within the last 25 years: Above is a half round lunette window. The end walls are raised above the roof line, and there is a two string stepped brick cornice along both sides.

This office was closed on the death of the owner (one of two brothers). A new house has recently been built to the rear and attached in an "L" shape.
