DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#101 is a two story, brick house detached on the right (alley) side, three bays wide and two bays in depth with a lower, two story, brick "L" shaped wing two bays deep and one in width with a side balcony. All brickwork is in common bond and there is some irregularity but no pattern of being raised on the exposed sidewall.

The front entrance occupies the left bay with a newer door, paneled enframement, and three pane overlight, and it is approached by an old brownstone sill and stoop.

The first floor front now has 1/1 sash windows with those above being shorter and with 2/2 sash. These are headed by grooved lintels and decorated by end blocks and carved roundels as above the door. Wing windows are of 6/6 sash with regular wood lintels and sills.

The front section roof now slopes to the rear and is decorated by a protruding Victorian cornice with ornately-cut modillions and incised designs in a Greek cross motif.

The building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
