DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#103 is a small, 2-1/2 story brick attached house, three bays wide and two bays in depth with a two story, brick "T" shaped wing, one bay wide and four bays in depth and a rear balcony.

The front entrance occupies the center bay with a four panel door, paneled enframing and narrow overlight. Front windows now have 1/1 sash with channeled lintels decorated by end blocks with carved roundels, as on #101. Rear area windows are either of 6/6 or 1/1 sash headed by two row segmental brick arches.

The front section has a steep, metal "A" frame roof resting on two string brick cornices, and a small enclosed chimney rises from the right side.

This house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.

An enclosed passage to the rear yards occupies the left bay.
