**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick pair of houses now detached on the left side. It is five bays wide and two bays in depth with two story brick "U" shaped wings, three bays in depth, 1-1/2 bays wide and newer extensions. #104 retains a side balcony. All brickwork is in common bond and two date bricks bearing "1859" are in the front facade near the doorways.

Front entrances occupy the second bay from each end with four panel doors, paneled enframements and old four pane overlights. All house windows are of 6/6 sash with wood lintels and sills. Front lintels are adorned with peaked moulding at the top. The attic of #104 is lighted by a small, four pane window.

The front section has a steep "A" frame roof and double flue enclosed chimneys rise from each gable. The front roofline is decorated by an overhanging wood cornice and a moulded frieze below which is adorned by dentils. The wings have metal shed roofs.

The building rests on a very low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
