DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#105 is a 2-1/2 story attached house of brick, three bays wide and two in depth with a 2-1/2 story brick "L" shaped wing, 1-1/2 bays wide and three bays deep with a side balcony. The front brickwork is laid in Flemish bond. The simple, front entranceway occupies the left bay with a newer door and narrow overlight. Most house windows are of 1/1 sash with several 6/6 windows remaining on the rear, and all have wood sills and lintels as above the doors. An old pair of paneled shutters also remains on the rear.

The front section has a steep sloped, "A" frame roof resting on three string brick cornices and a wide enclosed chimney rises from the right gable. The wing has a steep sloped metal shed roof. The house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
