DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#108 is a two story, brick house detached on the right, three bays wide and one bay in depth with a two story, frame, "L" shaped wing, two bays wide and approximately five bays in depth with a long side balcony and newer extensions. Brickwork is in common bond and the wing is sheathed by asphalt and asbestos shingles.

The front entrance occupies the right bay with a newer door, a paneled enframement, and narrow overlight. All windows are of 1/1 sash with wood lintels and sills and front lintels are decorated by peaked moulding at the top as on #104 & 106.

The front roofline is stepped down and fronted by an overhanging Victorian cornice with moulded brackets and modillions. Incised panels on the frieze accent each bay.

The house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
