DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of brick houses detached on the right side, approximately five bays wide and two in depth with two story, brick "U" shaped wings, two bays wide and three in depth. There are side balconies.

All brickwork is in common bond and #109 has been restored. Simple entrances occupy the outer bays with newer doors, narrow overlights, and segmental brick arches. The center bay contains an enclosed passageway to the rear yards with the front gateway also headed by a segmental brick arch. All front windows are of 2/2 sash with flat brick arches. Those on the rear are either of 2/2 or 6/6 sash and have wood lintels and sills. The attic of #109 is lighted by two small, four pane windows. The front section has a steep "A" frame roof resting on three string brick cornices. #109 is sheathed by metal but #111 by asphalt shingles. Double flue enclosed chimneys rise from each gable. The building rests on a low fieldstone foundation.
