DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and two bays in depth with a two story, frame "T" shaped wing, approximately three bays square with side balconies. #110 is now sheathed with asbestos shingles on the front and asphalt shingles on the side and rear areas as is #112. The front of #112 retains the original wood siding channeled in a "stone block" design with side "quoins." Simple front entrances occupy the outer bays with newer doors, but rear doors remain with wood panels. Front and rear windows are mostly of original 2/2 sash and have louvered shutters. The attics are lighted by small windows or louvers in each gable.

The front section has a steep sloped, metal "A" frame roof and a small chimney rises from the center. This roof protrudes on the front and is adorned by a dentiled frieze, and the bays are divided and ended by small cut brackets. The wing has a low slope "A" frame roof. The building rests on a low fieldstone foundation and #112 is fronted by a herringbone patterned brick pavement.
