DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of attached brick houses, four bays wide and approximately four bays in depth with a two story, brick "T" shaped wing, approximately three bays wide and two bays in depth with end balconies. All brickwork is in common bond. The front entrances occupy the inner bays with newer doors and rectangular transoms. First floor windows on the front are very wide with #113 having 2/1 sash and #115 1/1 sash as are the regular windows above. These are crowned by three row header segmental brick arches as above the doors and two row header segmental arches on the second story. All are adorned by infills bearing raised panels and carved roundels. Rear windows are of 2/2 sash with similar heads.

The front section has a moderate slope, metal "A" frame roof resting on three string brick cornices. Double flue chimneys are enclosed in each end wall. The wing roof is also of metal and with a low slope "A" frame.

The building rests on a rather low, brick-faced fieldstone foundation.
