DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#124 is a 2-1/2 story brick house detached on the left (E) side, three bays wide, two bays in depth with a two story brick "L" shaped wing, four bays deep, 1-1/2 bays wide with a one story, one bay square brick extension and a side balcony. All brickwork is in common bond.

The simple front entrance occupies the right bay with a four panel door and narrow overlight. All front windows are now of 1/1 sash with wood sills and lintels bearing end blocks and carved roundels, as above the door. Rear windows remain 6/6 sash with wood lintels and sills. The attic is lighted by a small, four pane window in the left gable.

The front section has a moderate slope, metal "A" frame roof resting on three string brick cornices with the center row on the front being laid in a decorative sawtooth design. Double flue, enclosed chimneys rise from each end wall. The house rests on a low, fieldstone foundation.
