DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an attached pair of 2-1/2 story brick houses, four bays wide and two bays in depth with newer, turn-of-the-century, two story, brick "U" shaped wings, 1-1/2 bays wide and three in depth with end balconies. All brickwork is in common bond.

Newer doors occupy the inner bays with an enclosed passage to the rear yards in between. #129 is approached by an old cast iron porch. All house windows are now of 1/1 sash with wood lintels and sills. Some of the rear area lintels are adorned by end blocks with carved roundels. Most windows are protected by either louvered or old paneled shutters.

The front section has a steep, metal "A" frame roof resting on two string brick cornices and small enclosed chimneys rise from each end wall.

The building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
