DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#133 is a two story, detached brick house, two large bays wide and two bays in depth with a two story, brick "L" shaped wing, one bay wide and four narrow bays in depth with a side balcony. All brickwork is in common bond. A round arched doorway with a paneled door occupies the right bay (E) side by a double window with a moulded mullion and with a segmental arch. All front windows are of 1/1 sash and those on the second story are double with individual round arches. All are topped by three rows of headers as is the door. Rear area windows are of 2/2 sash with two row header segmental arches, and there are four panel doors with narrow overlights.

The front section roof slopes to the rear with a Victorian "V" shaped cornice decorated by bands of beaded mouldings and incised designs. The wing roof is a low shed type.

The building rests on a rather high fieldstone foundation.
