DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#3 is a small 1-1/2 story detached brick cottage three bays wide and one bay in depth with a 1-1/2 story brick "L" shaped wing approximately two bays square. It probably originally had an overhang like its neighbor, but a bathroom extension was added. All brickwork is in common bond.

A newer front door occupies the center bay but retains the old paneled enframing and four pane overlight. Windows are of 6/6 sash with wood lintels and sills and pairs of vertical six pane windows light the attic from each gable.

The steep slope metal "A" frame roof rests on two string brick cornices and small enclosed chimneys rise from each end. The wing has a shed roof.

This building rests on a fieldstone foundation.
