#11 is a two story detached frame house three bays wide and one bay in depth with no wings and is sheathed with German siding.

A newer door lies between the first and second bays from the right (north) side between off-centered 2/2 sash windows. Above are three similar, but evenly spaced windows.

The metal roof slopes to the rear and is fronted by a plain boxed cornice. This house rests on a very high fieldstone foundation.
